## April 26 CCCA General Meeting

County Board Member Erik Gutshall talked about the challenges facing Arlington County and responded to questions from attendees. Particular concerns were raised about: the impact of a potential Amazon HQ2 on Crystal City; affordable housing; and budget impact on Crystal City projects. He emphasized that residents should engage in the ongoing Capital Improvement Process (CIP) if we really want to have the 18<sup>th</sup> Street Park developed and prevent the loss of our beloved Connection Pop-Up Library. In our April Newsletter, we published the March 30 letter from the Crystal City Citizens Review Committee (CCCRC) to the County Board, expressing concern that the proposed budget will seriously limit resources for investment in the Crystal City 'economic engine' due to a reduction in the TIF (Tax Increment Financing) rate of income from Crystal City returning to Crystal City development projects. [Weigh in on the CIP by May 16 for issues of importance to Crystal City like The Connection Library, the 18<sup>th</sup> Street park, and the bridge to the airport.]

Assistant County Manager for Communications and Engagement Bryna Helfer then presented the new Six-Step Public Engagement Guide (see article below) and urged residents to follow the issues on various social media and get more engaged. (see article below on what those media are). Erik Gutshall seconded this urging, joking that if something is important to us, we should "show up with pitchforks at meetings" to defend our interests.

# Crystal City Development and Planning Issues

## Sad Loss of The Connection Library



### **Are you aware that we are going to lose our beloved Pop-Up Library, The Connection, by the end of June?**

**Editorial:** The library opened across from Au Bon Pain in the Underground in the Fall of 2016, with a projection of being open only for a year as a Pop-Up library. It was the direct result of strong support by attendees at our CCCA meeting November 2015 to Diane Kresh, Arlington County Director of Libraries, when she first mentioned the idea. Since then, the library has become an integral part of our community for residents and workers alike and the number of visitors has consistently gone up; it's always busy.

Unfortunately, The Connection was funded by discretionary one-time use County funds, and the County Board insists that it was never intended to be permanent in Crystal City. Major Crystal City Developer Vornado supported the library by rent-free space and payment of utilities, and JBG Smith continues to do so. So the County's primary cost for the library, after initial set up, is only about \$100,000 for staff costs. Despite many efforts by the CCCA and residents to convince the County Board members to put permanent funding into the County budget, they chose not to. We received two reprieves until December 2017 and now until June 2018. This time, despite the outstanding success of the Pop Up Library in the Underground, the library will close at the end of June and we'll be left once again without our own library. Yes, we can walk over to Aurora Hills Library, but it's not the same—our Connection Library has been a hub of activity geared towards the demographic of high-rise dwellers, rather than single family homes. It is in fact the ONLY community facility and gathering place in Crystal City—and we're losing it.

So, it's sad to note, but it seems that Crystal City may again be losing out to other parts of the County with respect to budget and community facilities. ### **Crystal Drive/18th Street Developments**

**Editorial:** You've probably noticed work on the 1750/1770 Crystal Drive building as JBG Smith moves ahead with its plans to convert that building from office to rental apartments, including construction of additional stories and a new facade. The developer has proposed the rehab and expansion of the 1770 Crystal Drive building, and also is requesting approval for a two-story retail building at the corner of 18th and Crystal Drive. Earlier proposals that are

further along in the consideration process would provide improvements to the north on the same block, including a cinema, a grocery store and other retail which are generally viewed as positive for the neighborhood.

Important public hearings are the next steps and rare open space in our neighborhood is at stake.

It's critical that the pending proposal for a retail building in the open space be measured against the guidelines in the Crystal City Sector Plan (CCSP). The six-year effort to craft that Plan revealed just how inadequate open space is in Crystal City. The final Plan emphasizes the scarcity of open space planned for/envisioned in Crystal City – most of which currently is privately owned – and sets a goal to increase open space as redevelopment proceeds.

**The CCSP clearly shows a park along 18th Street which currently exists today and should remain in central Crystal City.**

**SO THE MAJOR ISSUE HERE IS THE PROPOSAL TO REPLACE PART OF AN IMPORTANT EXISTING/POTENTIAL OPEN SPACE WITH AN UNWANTED AND UNNEEDED RETAIL BUILDING.**

Your CCCA representatives have argued forcefully against this **premature** plan change that allows for a new structure in the park. The developer has not provided a justification for a retail building. The CCSP calls for street level retail all along Crystal Drive (from 15th Street to well south of 23rd Street) **and** at the ground level within the two existing office buildings that border the park's northern edge between 1770 and the Metro entrance. There are more than enough existing and planned retail opportunities without encroaching on valued open space. Equally important, there is **no funding** for park design, construction and maintenance, nor is there funding for a proposed new Metro entrance at 18th and Crystal Drive. If County officials agree to postpone the imposition of a

building in the park NOW, it can be revisited when a **need can be demonstrated AND funding for the park and Metro entrance becomes available.** The 1770 project and other improvements planned for the block north to 15th Street can of course proceed.

It is very important that County officials hear from Crystal City residents at the Planning Commission (meeting May 7) and the County Board (May 19 or 22). It's also important that the citizens appear in person, even if they don't choose to speak, to demonstrate public engagement and concern.

### Re-Imagining Crystal City/Pentagon City and Potomac Yard

The Crystal City Business Improvement District (CCBID) is embarking on a collaborative strategic planning process aimed at creating an Action Agenda to guide the continuing transformation of the Crystal City, Pentagon City and Potomac Yard area as a dynamic commercial marketplace and a more walkable and livable urban place. The planning process will be led by an appointed steering committee drawn from the BID's Board of Directors, civic associations, business and arts groups, and major property owners in the Pentagon City and Potomac Yards area along with other public and civic sector leaders and officials. *Members of the CCCA Executive Committee are participating in the working groups and will keep our membership informed. The final report is scheduled to be released in November.*

### Will Crystal City Get a Walkway to DCA?

Advocates call the proposed bridge a game changer. But at a potential cost of \$35 million, it won't happen without a major financial commitment from the County and/or others.

### Long Bridge Drive Utility Undergrounding & Roadway Realignment

The Long Bridge Drive utility undergrounding and roadway realignment are part of the Boundary Channel Drive Interchange project, which will upgrade the Boundary Channel Drive/I-395 interchange to more efficiently and safely serve future traffic generated by



Long Bridge Park and existing local and regional traffic generated by the Pentagon and I-395. The

interchange project also includes a connection to Long Bridge Park Drive and a bicycle connection from the Humpback Bridge to Long Bridge Park.

Phase 1 Utility Undergrounding is completed. The first phase of the Long Bridge Drive project removed the four overhead utility poles along the south side of Long Bridge Drive, underground the utilities and provided necessary utility connections for the future Long Bridge Park and aquatic, health and fitness facility.

Phase 2: Roadway realignment: The second phase will extend the reconstructed section of Long Bridge Drive (formerly Old Jefferson Davis Highway) to the Boundary Channel Drive/I-395 interchange. Long Bridge Drive will be realigned in order to tie into the future interchange at a less skewed and awkward angle. Improvements will include new sidewalks, bike lanes, landscaping, bus stops and street lighting.

### Long Bridge Park Field #3 Renovations Begin April 23!

Renovations of Long Bridge Park Field #3 are scheduled to begin on Monday, April 23, 2018. The field will be closed for renovations for approximately 45 days. Field #3 has had very high use since the park opened over seven years ago. As part of the work, synthetic turf field surfacing will be replaced with new dual fiber

(monofilament and slit film) synthetic infill-type surfacing and will include new infill, lines, and field markings.

### Demolition of elevated Clark Street

The fly-over roads from 12<sup>th</sup> and 15<sup>th</sup> Streets to Route 1 have both been closed. The contractor is working on permit applications, noise and vibration monitoring, and site preparation and pre-demolition items. Once demolition begins, there will be temporary street closures and detours to accommodate removal of the bridge structure. The first major detour is expected to begin in late May or early June with the closure of westbound 15th Street at the Clark Street and Route 1 bridges. More information will be available as the bridge removal and detour dates are confirmed. There will be two-week advance notice before the start of detours.

### Potomac Yard Metro station is over budget and behind schedule

The Potomac Yard Metro station is going to cost \$52 million more than previously estimated and might not open for passenger service until 2022, Alexandria city officials said this week. Alexandria and Metro blame increases in the cost of building materials and labor, saying the previous price tag was based on 2015 construction costs. "Clearly we would have preferred to pay a lower cost as was estimated in 2015 ... but we are still in a solid position to move forward with this new station," said Craig T. Fifer, chief spokesman for the city of Alexandria, which is paying for construction of the now \$320-million project. [Read more here.](#)

The Boston and Washington, D.C., metro areas are the "most likely candidates" to win Amazon.com Inc.'s second headquarters, a study from New York-based The Conference Board concludes, based on real-time labor demand and advertised online job vacancies among the 20 markets vying to land HQ2. The e-commerce giant's HQ2 campus could house 50,000 high-paying jobs in an

### Here is one unlikely beneficiary if Amazon HQ2 were to land in Crystal City

One of the country's Ivy League institutions stands to benefit in a big way if Amazon.com (NASDAQ: AMZN) picks Crystal City for its highly touted and much-anticipated second headquarters. Yale University happens to own about 4.36 percent of all the common shares of Chevy Chase-based developer JBG Smith Properties (NYSE: JBGS), or about 5.1 million shares, according to recent Securities and Exchange Commission filings. And while the company currently trades at about \$34 per share, it could see a big boost if Amazon picks Crystal City, where JBG Smith controls virtually the entire office market. ## Arlington County Board Adopts FY 2019 Budget

The Arlington County Board today adopted a \$1.276 billion balanced General Fund Budget for Fiscal Year 2019 that includes no increase in the real estate tax rate. The Board largely accepted the \$8.4 million in spending reductions, \$6.6 million in fee and tax increases and \$5.5 million in funding realignments recommended by the County Manager in his [proposed budget](#). The 3.9 percent increase in residential property assessments in 2018 means that although the real estate tax rate will not rise, the average homeowner will see an increase in taxes and fees from \$8,446 to 8,742, a \$296 or 3.5 percent increase. ## Major Milestone: A New Six-Step Public Engagement Guide

The County's new "Six-Step Public Engagement Guide for Capital Projects" aims to strengthen engagement and communication processes across County government – for hundreds of capital projects both large and small. Recognizing there's no one-size-fits-all approach, the guide aligns the level of public engagement needed based on the characteristics, benefits and potential impacts of each project. The six-step process highlights how engagements should be planned, implemented and assessed.

Over the last year, the County Manager's office worked with both internal and external stakeholders to develop the guide. And in the last month, hundreds of staff across the County have been trained on the new guide. Starting April 2, the guide will be applied to new capital projects just coming online. The County also will incorporate engagement levels into the next Capital Improvement Plan.

## Arlington Ranked Best Place for Successful Women in the U.S.

The most successful women in the U.S. live in Arlington, according to a new study by the website SmartAsset. Arlington, Virginia takes the top spot. ## Water Pollution Control Plant Master Plan

The Arlington County Water Pollution Control Plant (WPCP) treats incoming wastewater flows for residents, businesses, and government agencies in the Arlington County sewer service area to protect public health and the environment. The residuals produced as a byproduct of the treatment process are currently stabilized using lime to produce Class B biosolids that are beneficially used through application on agricultural land. The previous Master Plan project (MP01) focused on implementing state-of-the-art technology for the liquid

treatment processes. This Solids Master Plan focuses on planning for the future of solids processing at the facility. The purpose of the Solids Master Plan is to provide a roadmap for Arlington County with long- terms goals and strategies to achieve those goals identified. The plan recognizes the potential for a regional solids management solution that might include partnership with other utilities. Potential partners including DC Water, Fairfax County, and others were contacted for interest; however, at the time of this report, no regional opportunity has emerged. The recommendations in this Solids Master Plan allow the County to proceed with the planning and implementation of a solids management strategy while continuing to explore potential regional opportunities that may arise. ### Capital Bikeshare Coming to Gravelly Point, Theodore Roosevelt Island

The Arlington County Board approved an agreement April 24 with the National Park Service to allow Capital Bikeshare stations to be located on park service land. The Memorandum of Understanding will allow the County to install bikeshare stations at Gravelly Point and in the parking lot of Theodore Roosevelt Island, part of a planned and funded expansion of Capital Bikeshare's network along the Mt. Vernon Trail. The paved trail stretches 18 miles between Rosslyn and George Washington's home at Mount Vernon.

The County now has just one Capital Bikeshare station on National Park Service land, near the Iwo Jima Memorial in Rosslyn, just north of Arlington National Cemetery. The agreement is part of a new permitting process for placing Capital Bikeshare stations on National Park Service land. [Read more here.](#)

### School Board Considering New policy on Name Changes

According to a group of alumni from the Washington-Lee High School, there is a current Arlington County School Board initiative to rename not only Washington-Lee High School, but fully one-half or more of the schools in the county. The group is expressing concern that the part of this process that will determine its outcome -- the promulgation of new school naming criteria -- will apply to existing schools as well as new schools. This process will be over by the first few weeks in May.

The group is urging all Arlington residents to consider the facts and attend the next APS meeting May 3 at 6:30pm at the School Board's new location, The Syphax Center off Washington Blvd: 2110 Washington Blvd .

The particular concern they are raising is that the naming criteria guidelines will be proposed to the school board by a staff committee and then approved by the school board in early May without input from the wider Arlington community. ### Beyer Seeks To Appease Aircraft Noise Concerns With Amendments

Congressman Don Beyer (D-Va.) has added several amendments to the FAA Reauthorization Act (H.R. 4) intended to reduce aircraft noise in the region. One of the amendments would provide for soundproofing “residential buildings located on residential properties that are subject to increased perceived noise levels as a result of the NextGen initiative of the Federal Aviation Administration.”

One of the amendments would charge the administrator of the Federal Aviation Administration with developing “a noise inquiry website... to receive, track, and analyze complaints on an ongoing basis from individuals in the National Capital Region.” A separate amendment proposes a monthly helicopter noise abatement working group, led by the FAA and with Department of Defense officials in attendance, to “collect, correlate, and identify trends” relating to regional helicopter noise.

Another amendment seeks to “review and revise helicopter flight paths, including those used by the Department of Defense and all military helicopters, identifying and issuing new official paths for the areas in which helicopters may be able to fly at higher altitudes.”
