

Four CCCA officers will be elected at the CCCA Annual General Meeting on November 16. As of November 1, the date that nominations closed, the following are applying:

For President: Christer Ahl



Christer has represented the Crystal City community in Arlington planning processes and on policy issues during the last fifteen years. He wants to enable our Civic Association to continue to draw on his vast experience and his insights by moving on to the position as President of our Civic Association.

From the time of his participation in the Crystal City Sector Planning, Christer has established strong relations with County officials, with landowner and business representatives, and with the leaders of the neighboring Civic Associations. Christer has gained their respect and trust, as evidenced by his many important appointments over the years.

Last year, Christer was appointed to serve as member of a countywide task force, developing recommendations on fundamental issues, such as demographic projections, future income sources, expected needs for County facilities and services, and processes for prioritizing such needs. Christer is also the Vice-Chair of the Crystal City Citizen Review Council, a County entity where all the stakeholder groups monitor progress in Crystal City. He also serves as a Board Member of the Crystal City Business Improvement District ('the BID'). Earlier, he was on the County's Parks & Recreation Commission.

Christer's educational background is in Business Administration, and he spent 30 years as Human Resources Manager at the International Monetary Fund. He also held senior positions in international sports during several decades.

For Vice President for Policy and Planning: Judy Freshman (no photo)

Judy has lived in Arlington for 40+ years and in Crystal City since 2007. Her interests and training (Master of Planning, UVA) have led her to membership on many County task forces and working groups, and she spent 12 years on the Planning Commission from 1983 to 1994. Currently, she is Chair of the Board of Zoning Appeals and has been a representative on the Crystal City Citizen Review Council (CCRC) since its inception in April 2011. Judy participated in the formation of the Crystal City Civic Association and has served as an ex officio member for several years, primarily monitoring long range and site development plan submissions in Crystal City and Pentagon City.

Treasurer: Diane Oksanen-Gooden



Diane Oksanen-Gooden is a candidate for CCCA Treasurer. She and her husband moved to Crystal City in 2013. Diane is a charter member of Crystal City Civic Association as treasurer. When the opportunity to start a civic association for Crystal City came up, she enthusiastically joined. Diane feels a civic association helps give a community a better sense of having an input into the local government by giving the community a common voice. Crystal City Development and Planning Issues

The next two articles show how important the November 16 CCCA meeting focused on rail transportation issues is.

Long Bridge Study and Crystal City Tracks



The situation: Long Bridge is a 2-track railroad bridge over the Potomac River. It is the only freight railroad bridge between the District of Columbia and Virginia. The next closest bridge is in Harpers Ferry, WV. The current bridge was built in 1904, and is owned and maintained by CSX Transportation. In addition to freight trains, the bridge is used by VRE and Amtrak. The District Department of Transportation (DDOT), in coordination with the Federal Railroad Administration (FRA), is completing a comprehensive study for the rehabilitation or replacement of the Long Bridge over the Potomac River.

What's happening now?: Scoping is the first step in preparation of the Environmental Impact Statement (EIS). A range of alternatives is still being considered. A final decision on a preferred alternative will not be made until the EIS process is complete. DDOT is leading the EIS for the Long Bridge project, which includes additional bridge capacity over the Potomac River and track improvements into Union Station. Virginia Department of Rail and Transportation (DRPT) plans to use Atlantic Gateway funding to construct six miles of a fourth main line track from Arlington, Virginia to Alexandria, Virginia. This alternative includes shifting track in curves where practical to gain greater speed,

improving crossings, signals, safety systems, and accommodating VRE platform improvements.

Public involvement for the study includes outreach at key project milestones such as the public scoping period which will be conducted in accordance with NEPA regulations. During Phase II, three rounds of community meetings are scheduled: The most recent was Community Meeting #2 (Public Scoping) held September 14, 2016. [See the 9 alternatives here:](#)

Possible Impact on Crystal City?

- Track expansion from 3 to 4 in Crystal City down to Alexandria
- Expansion of VRE station
- Greater frequency of train traffic


VRE Planning for Crystal City

From VRE's [September 2016 CEO Report](#):

"VRE is preparing to begin development studies to improve the Crystal City Station, their busiest destination station in Virginia. The two design priorities are to extend the existing 390-foot platform to 700 feet in order to accommodate the full length of an eight-car train and to relocate the platform between Tracks 2 and 3 so two trains can service Crystal City Station at the same time. Nearly two-thirds of Crystal City riders depart the station on foot, so enhancing pedestrian and bike access is vital. VRE also places a priority on enhancing regional connectivity throughout Northern Virginia via Metrorail or buses here.

On July 19, 2016, VRE and Arlington County staff met with the Crystal City Business Improvement District and Vornado Realty Trust to learn about changes anticipated at and around our station. VRE provided a briefing on the upcoming project to Arlington County Board Member Katie Cristol and Arlington County transportation and planning staff on August 4, 2016."

Long Bridge Drive Utility Work Starts



Construction has begun along Long Bridge Drive near Boundary Channel Drive. This work includes removing four overhead utility poles along the south side of Long Bridge Drive, undergrounding the utilities and providing utility connections for future improvements at Long Bridge Park. Work hours will be 9 am to 4 pm, Monday through Friday. During these hours, this section of Long Bridge Drive will be reduced to one lane. Crews will direct traffic through the work zone, and all lanes will reopen at the end of each work day. Undergrounding utilities is the first phase of the Long Bridge Drive project, which includes realigning the road and extending the reconstructed section of Long Bridge Drive to the Boundary Channel Drive/I-395 interchange.

Aurora Hills Community Center Renovation

The County has fixed firm dates for the closing of the Aurora Hills Community Center (AHCC) for renovation. Aurora Hills 55+ Programs will temporarily relocate to [Gunston Community Center](#) on Nov. 7. The renovations are expected to take approximately 8 months.

The Board voted 5 to 0 September 24 to approve a contract with D&A Contractors, Inc. for approximately \$555,800 to provide general construction services for interior upgrades at the Aurora Hills Community Senior Center and Library, located at 735 18th Street S. Upgrades to the facility will include a new kitchen, ADA compliant bathrooms and reception desk, circulation desk, an administrative office and two storage rooms, new paint and flooring, additional storage cabinets and related electrical upgrades and finish work. A video sneak peek at the future Reagan National Airport

Reagan National will be getting a major facelift in the next few months, part of \$1-billion modernization of the 75-year-old airport. Plans include a new terminal to house short-hop flights on the north side of Terminal C, currently home to the airport's executive offices. The project also includes space for new security checkpoints. On Wednesday, members of the Metropolitan Washington Airports Authority's board of directors, got a preview of what the new National will look like when work is completed in 2021. Vornado Spin Off/ New JBG Company in Crystal City

VORNADO REALTY TRUST (NYSE:VNO) ("Vornado") announced October 31 that its Board of Trustees has approved a tax-free spin-off of its Washington, DC business, currently known as Vornado/Charles E. Smith and that it has entered into a definitive agreement to merge SpinCo with the operating company and certain select assets of The JBG Companies ("JBG"), a leading Washington, DC real estate company. The combined company will be named JBG SMITH Properties. It will be the largest, market-leading, best-in-class, pure-play Washington, DC real estate company. Read the full article [here](#). You all know that you are voting for a new President and Vice President of the United States on **November 8**. Also on the ballot will be voting for the House of Representatives (8th District, one seat), County Board (one seat) and School Board (two seats). The ballot will also include a special election for two proposed Virginia Constitutional amendments and four County bond referenda, totaling \$316 million. The projects included in these bond questions are components of the [County's ten-year Capital Improvement Program \(CIP\)](#) and [Arlington Public Schools' CIP](#), both adopted in July 2016. VDOT Project Update: I-395 HOV Tolling

The Arlington County Board received an update October 18 from state transportation officials regarding the potential traffic, environmental and fiscal effects to Arlington resulting from the [I-395 Express Lanes Northern Extension](#). The state project to add a third high occupancy vehicle (HOV) lane and convert the three HOV lanes to managed HOV/toll lanes is currently under environmental review. County staff have been working closely with the Virginia Department of Transportation (VDOT) to ensure the I-395 project's environmental review includes a thorough analysis of impacts to Arlington. VDOT has indicated the additional express lane will be constructed completely within its right of

way. County staff will provide a detailed analysis for the County Board in December regarding traffic impacts to Arlington, impacts from possible noise mitigation, and sufficient transit funding. [See full information here.](#)

I-95/I-395 Transit/TDM Study - online survey

The Virginia Department of Rail and Public Transportation held an open house in Arlington last month to discuss its I-95/I-395 Transit/Transportation Demand Management (TDM) study. As part of that review, to be released for public comment in December, the department is seeking [online input](#) on transit and TDM needs along the I-95/I-395 corridor.

Pedestrian, Bicycle Access and Safety with More Street Types

On October 15, the Arlington County Board adopted proposed amendments to the Master Transportation Plan Street Element, incorporating two innovative changes: a new pedestrian priority street type — a car-free street that provides pedestrians access to adjacent buildings — and “shared streets” — for pedestrians, bicyclists and low speed vehicular traffic. These amendments will accommodate street variations as envisioned in the [Rosslyn](#) and [Courthouse](#) Sector Plans and provide guidance for potential use in other parts of the County. The idea of new street types is the result of considerable public involvement. The two new street types were initially envisioned during the development of the sector plan updates, with the names and definitions further refined in hearings by the Arlington Planning and Transportation commissions.

Now that these changes have been accepted, the new street types can be applied elsewhere in the County when approved through a community planning process and action by the County Board. [Read more here.](#)

Arlington Names New Director of Management and Finance

Stephen J. Agostini has been named Arlington County's new Director of Management and Finance, and will start November 17. He will be responsible for approximately 50 staff involved in the County's financial operations, including management and budget, accounting, purchasing, and real estate assessment.

Arlington is one of only a handful of counties across the nation that maintains the highest debt rating available – Aaa/AAA/AAA from all three credit ratings agencies. For 16 years, the County has won praise from the ratings agencies for its sound financial operations and management. [See news release here.](#)

On October 20, Metro General Manager Paul J. Wiedefeld joined state and local officials from Maryland and Virginia along with the Peterson Companies to celebrate the launch of the NH2 Metrobus service between Alexandria and National Harbor starting on Sunday, October 23. Metro, Alexandria and Fairfax County officials boarded the NH2 for a preview ride from the Huntington and King Street-Old Town stations to National Harbor, where Maryland officials got on board

to complete the trip. The new route is operated by Metro and funded by National Harbor developer Peterson Companies, the City of Alexandria, Fairfax County and the Maryland Department of Transportation in a unique public/private partnership.
