## Next CCCA Meetings

How can you help inform the process? What are the next steps?**

# Crystal City Development and Planning Issues

## OPTION 2 FOR VRE STATION WINS BOARD APPROVAL



The County Board voted **September 19** to:

1. "Accept Option #2 as VRE's preferred station location"
2. Request VRE to "engage with the Arlington County Board and residents of Crystal City at the concept design and before site investigation, to review all elements of the concept design scope including noise; and further request that the VRE present the finalized concept design to the Arlington County Board and residents for final comment and opinion before finally selecting that design for construction."
3. Additionally, to direct "the County Manager to initiate a process to engage CSX on mitigating noise from the operation of their rail lines in Crystal City, Arlington."

*Hearing of the issue (VRE, County staff, Planning Commission, Transportation Commission presentations, citizen comment) lasted 2 1/2 hours. You can watch the discussion at hour 3:41 to 6:11 on [YouTube](#).*

*This is certainly not the way we wanted the issue to end, but we still have a chance for mitigation efforts due to the station location in the next stage. We will also need to keep reminding the County of its direction to engage CSX on noise mitigation.*

### Airport Access Feasibility Study



The Crystal City Business Improvement District (BID) has funded a feasibility study for a new pedestrian/bike access from Crystal City to the airport and held two meetings

### Moving Forward on Long Bridge Park Facility

There is a County process underway to select a winner of



a bidding process for the design and construction of the indoor Aquatics/Fitness/Health facility in Long Bridge Park, which after years of planning and a 'false start' due to a projected budget overrun was halted a couple of years ago. The revised process is

based on what is known as a Design/Build approach, under which a combination of a construction company and one or more design/architectural firms commit to produce a facility with the required features and the agreed design quality within a pre-established price.

Five bidders were determined to be 'qualified', in terms of prior experience and capacity for this kind of project and four were interviewed at the end of August by the Long Bridge Park Selection Advisory Committee (LBPAC) on their proposals. These finalists will, starting in September, further develop their proposals, and be interviewed by the Long Bridge Advisory Committee so that a final comparison and evaluation can be made.

The current timetable is:

**October 18:** Review by County Board, LBPAC and Public Facilities Review Committee (PFRC)

**October 19:** Public meeting, 2011 Crystal Drive, 11<sup>th</sup> floor; followed by 10 days for feedback on proposals

**November:** County Board votes to choose one design

**December-January:** refinement of proposal

**January/February:** LBPAC/PFRC review

**January-December:** design

**July 2018:** construction begins

**Late 2020/early 2021:** project completion

### Long Bridge Park Public Meeting October 19

**Plan to come to the October 19 meeting to emphasize what will matter to us in Crystal City.** It is increasingly

obvious that there are competing interests: those of residents in Crystal City and those in other areas of the County. We want to be supportive of the process, but we also need to weigh in with OUR interests in Crystal City:

e.g., park features, public space indoors, "destination" for people in the area, fitness space, and a therapy pool.

Other parts of the County, such as sports folks, might prioritize hugely expensive features such as a 10m diving tower, lots of spectator space for rare events, designs to match international standards rather than U.S.

competition standards, etc. Such features could cost money which would force the bidders to scrap features of greater interest to us in Crystal City.

### How Victor Hoskins will use lessons from Nestle to lure Amazon to Arlington

Amazon's recently launched quest to put a second headquarters somewhere in North America has jurisdictions nationwide scrambling to make a case by the Oct. 19 deadline. is a priority on Amazon's Request for Proposals. Arlington County Economic Development Director Victor Hoskins is still coming down from 2017's big "get": the deal that will bring Nestle USA to Rosslyn. While a fraction of the Nestle deal's size, Hoskins said there's no reason Arlington should not be considered a serious contender for another headquarters opportunity — the biggest of them all. Hoskins, like his competition for the \$5 billion HQ2, is silent on specifics such as what the county might offer as an incentive and where in Arlington the potential 8 million-square-foot campus could go. But he said he will employ the same tactics he used to get Nestle. That is, highlight the region's brainpower since access to a tech-savvy and educated workforce Greater Washington's impressive demographics aside, most area jurisdictions are still submitting plans individually. In Northern Virginia alone, Arlington County, Loudoun County and Alexandria have said they will submit proposals. Fairfax County will likely do so too, joining the District, and Montgomery and Prince George's counties in Maryland. [Read more here.](#)

### JBG's Partial rebranding of Crystal City

JBG-Smith, which merged with Vornado Realty Trust's D.C. business unit in July, has filed the first development application with Arlington County for the North District, bounded by Crystal Drive and Route 1, from 15th to 18th

Street, adjacent to the Crystal City Metro station. This initial application seeks to add 120,000 square feet of retail across several properties near 18th Street and Crystal Drive, with roughly 50,000 square feet set aside for Alamo Drafthouse Cinema, as WBJ previously reported. The developer is hoping another 15,000 to 20,000 square feet will be taken by a specialty grocery store. [Read more here.](#)

## "Revisoning" 23<sup>rd</sup> Street "Restaurant Row"

County Board members Jay Fisette and Christian Dorsey met with representatives of the business community on 23rd Street (west of Route 1) and of the three 2202 civic associations September 28 to brainstorm a "revisoning" of "Restaurant Row."



The street is included in Arlington County's delineation of Crystal City and figures in the 2010 Crystal City Sector

Plan. Participants discussed what are the challenges, the assets, and the opportunities for revitalizing the street.

The street has a certain character and could be deemed "Historic Restaurant Row," since locally owned businesses have occupied this block for over 40 years, mainly consisting of Restaurants/Bars, now with shopping, salons and more. There is a [Facebook page](#) but no website. The block faces challenges of street congestion, isolation due to Route 1 from the main part of Crystal and Pentagon Cities. Solutions to some of the biggest challenges may require considerable funding and years of planning. But next steps seem to be for the business community to develop a vision for the street and a strategic plan to see what can be done in the near future.

## Contract for elevated Clark Street demolition

The Board voted unanimously September 16 to approve a \$6.6 million contract with Neuber Environmental Services, Inc., to remove the elevated South Clark Street roadway in Crystal City between 12th and 20th Streets South. Removing the structure will improve the street network and create more development space in Crystal City, in accordance with the Crystal City Sector Plan.

After the roadway and its overhead bridges, abutments



and retaining walls are removed new retaining walls, grass pavers and stormwater facilities, landscaping, traffic signals at 20th Street South and Route 1 will be added. Demolition is anticipated to start in fall 2017, with completion scheduled for late summer 2019.

The demolition also will create more space for pedestrian and bicycle access improvements to the Crystal City Metro Station, which is part of a future project. Funding for the demolition project comes from an Arlington fund dedicated to infrastructure investment in Crystal City. [See the project page here.](#)

## Potomac Yard Metro station delayed to 2021

A plan to build a Metro station in Alexandria's growing Potomac Yard community is moving along, but the projected opening has again been pushed back, this time to spring 2021. Alexandria officials said the latest delay came when transit officials determined more time than anticipated would be needed to award a contract. The transit agency says it anticipates awarding the contract next spring, with construction to take about three years.


## Ulta Beauty, Basic Burger Coming to Pentagon Row

## Newest New Polling Station for Precinct 006

Those of us in the north end of Crystal City may be starting to think of our elections polling station as a moveable feast. After years of voting at WaterPark

When the management for both buildings decided not to host the polling station any more, the County scrambled to find another site. Unfortunately, none of the suitable condo or apartment buildings wanted the hassle either.

So, our newest polling station is the Gallery Underground (Studio Red) at 2100 Crystal Drive. Look for Room 25A in Section B on the Underground map. Some of you may have attended painting classes there or the VRE station public meetings last June. When you enter from *We the Pizza* and pass the *Library* on your right, turn left and it's the first glass-windowed area on the right, next to Au Bon Pain. ## Why Does Virginia Hold Elections In Off-Off Years?

Virginia is one of only five states in the U.S. to hold its statewide elections in years that do not coincide with a presidential or congressional mid-term election, and one of only two — New Jersey being the other — to elect a new governor this year.

But why? Is Virginia purposely trying to cut against the grain, to be a contrarian commonwealth? Or did legislators pick the off-off-year election schedule — so named because no federal candidates are on the ballot — because it's objectively better than aligning with presidential or congressional contests? ### Ribbon Cut for New Arlington Transit Facility

Arlington County Board Chair Jay Fiset, along with senior County staff and officials from Virginia's Department of Rail and Public Transportation, helped celebrate the completion of the new



Arlington Transit (ART) Light Maintenance Facility with a ribbon cutting September 26. At the ceremony, attendees had the opportunity to explore the new two-story, state-of-the-art facility including the light-duty maintenance bay and compressed natural gas fueling station – and even experienced the bus wash first-hand.

ART is growing and provided more than 3.4 million rides on 17 bus routes over the past year. Fleet and service expansion is planned for the next 10 years. The facility provides crucial storage space for 25 of 65 buses, fueling, maintenance and wash services for the entire ART fleet.

### County Board Bans Wild and Exotic Animals as Pets

On September 19, the Arlington County Board amended



Chapter 2 of the County Code to prohibit residents from keeping wild and exotic animals as pets. Current owners can retain wild and exotic pets. The Code

amendment creates a registry to allow owners of wild and exotic animals already in the County to legally retain them. The ban does not include non-venomous snakes, but a set of care, handling and enclosure standards were put in place for non-venomous snakes weighing more than 25 pounds. ### Police to Participate in National Prescription Drug Take-Back Day on October 28, 2017

On Saturday, October 28, 2017 from 10 a.m. to 2 p.m., the Arlington County Police Department, Arlington County Sheriff's Office and the Drug Enforcement Administration (DEA) will give the public its 14th opportunity in 7 years to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your pills for disposal to the listed sites. The service is free and anonymous, no questions asked. Please note: The DEA cannot accept liquids, needles or sharps. Only pills or patches will be accepted.)

### FRAUD ALERT: Credit Card Skimmers

The Arlington County Police Department is warning the public about skimming devices used to steal banking and personal information. At approximately 2:50 p.m. on Monday, September 18, police were dispatched to the Exxon Gas Station in the 4000 block of Old Dominion Drive for the report of a credit card skimming device located inside a gas pump. Citizens having used this location have reported fraudulent activity on their bank statements. Police are encouraging anyone who has

used this gas station to review their bank statements for any fraudulent activity. If fraudulent activity is located, report to police by calling the Emergency Communication Center at 703-558-2222 or file an online police report.

Citizens can take the following crime prevention steps to avoid skimmers at gas stations: Skimming devices have become more sophisticated. In most cases, the skimmers are being placed inside the machine and are undetectable without opening the pumps.

- Pay inside at the gas station, rather than at the pump.
- Always pay using a credit card instead of a debit card. Credit cards have better fraud protection, and the money is not deducted immediately from an account. If using a debit card at the pump, choose to run it as a credit card instead of putting a PIN number in. That way, the PIN number is safe.
- Consider purchasing a refillable prepaid card to purchase gas at the pumps.
- If you have not already switched to a chip reader on your credit card, do so.
- Regularly check your bank statements and if you notice fraudulent activity, notify the bank so they can begin an investigation.

Criminals will use a variety of different scams and the Arlington County Police Department wants the public to remain alert so you don't become a victim. ### Arlington Plans October Revenue Bond Sale

The Arlington County Board today approved the sale of Series 2017 Revenue Bonds, to be issued through the Arlington County Industrial Development Authority (IDA). These are long-term, subject-to-appropriation bonds, which the County uses to finance major capital projects. Proceeds of the sale will finance a range of County capital projects, including:

- \$34 million to purchase the "Buck Property" industrial-zoned property on North Quincy Street, across from Arlington Public Schools' Education Center.
- \$10.5 million would be used to finance the acquisition, design and construction of an office building at 2920 S. Glebe Rd. The County plans to use the building as the new home of the Head Start program that will be displaced from its home at 1800 N. George Mason Drive when the County's

Edison/Drewry complex is transferred to Virginia Hospital Center.

- \$6 million to finance upgrades to the County's Assessment and Collection system and Enterprise Payments System – the first in a series of technology improvements that are part of the County's goal to rework internal processes to increase worker productivity and enable a digital workplace.

\$38.3 million in refinancing of existing bonds, saving more than \$3.8 million under current conditions.

## Hogan outlines \$9B plan to add lanes to Beltway, I-270 and I-295

Gov. Larry Hogan announced September 21 a \$9 billion plan to address gridlock on suburban Maryland's busiest highways, bringing added capacity — and tolls — to Interstate 270, the Capital Beltway and the Baltimore-Washington Parkway. The concept calls for four new lanes on I-270 from the Beltway to Frederick, four new lanes on the Beltway from the American Legion Bridge to the Woodrow Wilson Bridge, and, if the National Park Service is willing to give up control, four lanes on I-295 between Baltimore and D.C. The new lanes would be tolled, and built — like the Express Lanes in Virginia — by

a private contractor, making this a public-private partnership, or P3. The announcement kicks off the search for a private partner, or partners, to design, build, finance, operate and maintain the new lanes, according to a release. [Read more here.](#)
